We provide subsidies to ensure everyone can take part. A lot of the expenditure is on increasing the CPD for staff to upskill them as that is a sustainable use of the expenditure. The purchase of equipment is to ensure all children for now and in the foreseeable future can enjoy a wider experience of PE.
